Contributors

Roger Anyon is a cofounder of Heritage Resources Management Consultants. He was the director of the Zuni Archaeology Program from 1985 through 1996. He is a member of the Smithsonian Institution Native American Repatriation Review Committee and serves on the executive board of the Society for American Archaeology. His master's degree in anthropology is from the University of New Mexico.

Robert E. Bieder is a professor in the School of Public and Environmental Affairs at Indiana University. He has also taught in Southeast Asia and held two Fulbright professorships to Germany and one to Hungary. The author of several books and articles, including *Science Encounters the Indian, 1820–1880: The Early Years of American Ethnology* (Norman: University of Oklahoma Press, 1986), he is a former Newberry Library and Smithsonian Institution Fellow.

Suzanne J. Crawford is completing a doctorate in religious studies at the University of California, Santa Barbara.

Vine Deloria Jr. is a professor of history at the University of Colorado at Boulder. He is a member of the Standing Rock Sioux tribe and the author of numerous books, such as *Behind the Trail of Broken Treaties* (Austin: University of Texas Press, 1985), *Custer Died for Your Sins* (Norman: University of Oklahoma Press, 1988), and *The Nations Within: The Past and Future of American Indian Sovereignty* (Austin: University of Texas Press, 1998).

Kurt Dongoske has twenty years of professional experience in archaeology and cultural resource management, including seven years as tribal archaeologist with the Cultural Preservation Office of the Hopi Tribe. He also has twelve years' experience in human osteological analysis. He received an M.A. degree in anthropology from the University of Arizona.

Walter R. Echo-Hawk, a member of the Pawnee tribe in Oklahoma, is a senior staff attorney at the Native American Rights Fund (NARF) in Boulder, Colorado. Specializing in religious freedom issues, he was a major contributor in the passage of the Native American Graves Protection and Repatriation Act (1990), the Smithsonian repatriation provisions of the National Museum of the American Indian Act (1989), and burial protection and reburial laws in Nebraska and Kansas. He is coauthor of *Battlefields and Burial Grounds: The Indian Struggle to Protect Ancestral Graves in the United States* (Minneapolis: Lerner, 1994).

T. J. Ferguson is a cofounder of Heritage Resources Management Consultants. He served as director of the Zuni Archaeology Program from 1977 to 1981 and as acting director in 1984–85. Since 1984 he has conducted archaeological and ethno-historical research on the Zuni Indians as a research associate of the Zuni Archaeology Program. His Ph.D. in anthropology is from the University of New Mexico.

Lynne Goldstein is professor of anthropology and chair of the Department of Anthropology at the University of Wisconsin-Milwaukee. The majority of her research has been in the Midwestern United States, focusing on native cultures at around A.D. 1000, but she has also directed excavations of an Irish cemetery and a historic Russian-American cemetery. Goldstein is a former secretary of the Society for American Archaeology (SAA), and she also serves as chair of the SAA's Repatriation Task Force.

Curtis M. Hinsley Jr., who lives and works in Flagstaff, Arizona, is Regents Professor of History and Applied Indigenous Studies at Northern Arizona University. He is the author of *The Smithsonian and the American Indian: Making a Moral Anthropology in Victorian America* (Washington DC: Smithsonian Institution Press, 1994) and numerous articles on the history of American anthropology and archaeology. Currently he is at work with archaeologist David R. Wilcox, of the Museum of Northern Arizona, on a cultural history of the Hemenway Southwestern Archaeological Expedition (1886–89).

Ira Jacknis is associate research anthropologist, Hearst Museum of Anthropology, University of California at Berkeley. Previously, as assistant curator for research at the Brooklyn Museum, he was cocurator of "Objects of Myth and Memory," an exhibition of Stewart Culin's American Indian Collections.

Keith Kintigh, a Southwestern archaeologist, is now associate professor of anthropology at Arizona State University. As the chair of the Society for American Archaeology Task Force on Repatriation, he was involved in the legislative process leading to the passage of NAGPRA. His research focuses on organizational developments during the late prehistoric periods in the Zuni area and on the development and use of quantitative and formal methods in archaeology.

Anthony L. Klesert received his graduate education at Southern Illinois University at Carbondale, where he worked as a staff member for the Black Mesa Archaeological Project in northeastern Arizona. Upon graduation Klesert worked for a private consulting firm in southwestern Colorado, and he has been the director of the Navajo Nation Archaeology Department since 1982. His interests include CRM law on Indian lands and archaeological methods.

Edmund J. Ladd was a member of the Zuni tribe and published extensively on the archaeology of the Hawaiian Islands and the ethnography of the Zuni Indians. He was involved in repatriation issues for more than a decade and worked as a repatriation consultant for the Smithsonian Institution's Repatriation Office and the National Museum of the American Indian. He held a master's degree in anthropology from the University of New Mexico.

Patricia M. Landau is a former graduate student in the Department of Anthropology at Texas A&M University.

Robert J. Mallouf has been a professional archaeologist for twenty-seven years. He currently serves as director of the Center for Big Bend Studies, Sul Ross State University, and served as Texas state archaeologist from 1982 to 1995. Mallouf carried out his studies at Howard Payne University in Brownwood, Texas, the University of California at Berkeley, the American University of Cairo, Egypt, and the University of Texas at Austin. He has conducted archaeological research throughout Texas and in areas of Kansas, Oklahoma, and northern Mexico.

Clement W. Meighan was a professor of anthropology at the University of California, Los Angeles. He was the author of many books on the archaeology of California and was coeditor of *Chronologies in New World Archaeology* (New York: Academic Press, 1978).

Devon A. Mihesuah is professor of American Indian history and applied indigenous studies at Northern Arizona University in Flagstaff. She is a member of the Oklahoma Choctaw Nation and editor of the *American Indian Quarterly* and has been involved in the repatriation issue for fifteen years. Her works include *Cultivating the RoseBuds: The Education of Women at the Cherokee Female Seminary, 1850–1909* (Urbana: University of Illinois Press, 1993), *American Indians: Stereotypes and Realities* (Atlanta: Clarity Press, 1996), *Natives and Academics: Researching and Writing about American Indians* (Lincoln: University of Nebraska Press, 1998), and *The Roads of My Relations* (Tucson: University of Arizona Press, 2000).

Shirley Powell is an adjunct professor of anthropology at Fort Lewis College. She served as director of Northern Arizona University's Archaeology Laboratory between 1987 and 1992. Powell is the author of several books and articles about archaeology and has numerous years of experience with contract archaeology—including directing Peabody Coal Company's Black Mesa Archaeological Project in northeastern Arizona.

James Riding In is associate professor of justice studies at Arizona State University in Tempe. A member of the Pawnee Tribe of Oklahoma, he is the author of numerous articles focusing on repatriation.

D. Gentry Steele is professor of anthropology at Texas A&M University and author of *Anatomy and Biology of the Human Skeleton* (College Station: Texas A&M University Press, 1988) and of fifty articles and research reports dealing with human osteology. He has previously served as president of the Council of Texas Archaeologists. His current areas of interest include human osteology and North American anthropology with emphasis on the development of techniques for the analysis of human skeletal remains and the analysis of prehistoric populations.

Jack F. Trope is a partner in the law firm of Sant'Angelo & Trope, P.C., in Cranford, New Jersey, where his primary specialty is in the field of American Indian law. Previously he was senior staff attorney for the Association on American Indian Affairs in New York City from 1985 to 1991. In that capacity he

was integrally involved in the negotiations that culminated in the enactment of NAGPRA.

Larry J. Zimmerman is department executive officer, American Indian and Native Studies Program, University of Iowa. He has authored or edited numerous books, journals, articles, and technical reports on topics related to Plains archaeology. He is currently executive secretary of the World Archaeological Congress.
